The COAG Health Council (CHC) agreed to regulate paramedics under the National Registration and Accreditation Scheme. The proposed regulation includes the setting of professional standards for conduct and entry to the labour force for paramedics. An adequate Regulation Impact Statement was not prepared to inform the decision by the CHC, resulting in the decision being assessed as non-compliant with the Council of Australian Governments' best practice regulation requirements.

Consumer Affairs Ministers agreed to the introduction of a new information standard requiring eggs labelled as 'free range' to have been laid by hens with meaningful and regular access to the outdoors, with an outdoor stocking density of 10,000 hens per hectare or fewer. The information standard will also require producers to prominently disclose the outdoor stocking density of hens laying free range eggs, allowing consumers to easily compare the practices of different egg producers.

The Council on Federal Financial Relations (CFFR) announced that the threshold for Goods and Service Tax (GST) on imported goods would drop from \$1,000 to zero from 1 July 2017. In making this decision the CFFR did not comply with the Council of Australian Governments' best practice regulation requirements to prepare a RIS.

Food Standards Australia New Zealand (FSANZ) approved a variation to the Australia New Zealand Food Standards Code to prohibit the retail sale of raw apricot kernels to consumers, and to further regulate kernels that are to be added to food as an ingredient.

On 9 May 2016 the Medical Board of Australia issued mandatory guidelines to apply to all registered medical practitioners who perform cosmetic medical or surgical procedures. An adequate Decision RIS was not prepared to inform the decision, resulting in the decision being assessed as non-compliant with the Council of Australian Governments' best practice regulation requirements.

The Meeting of Environment Ministers consented to the development of a national cooperative framework to implement a national standard to address environmental risk management of industrial chemicals in Australia. Under the agreed national cooperative framework, the national standard will be established under Commonwealth legislation with automatic adoption under jurisdictional legislation for implementation and compliance.

Food Standards Australia New Zealand released a Council of Australian Governments (COAG) Regulation Impact Statement (RIS) for a proposal to regulate food containing lupin as a food allergen.
