#### Compliance with COAG Regulation Impact Statement (RIS) Requirements: 2016-17

The Office of Best Practice Regulation (OBPR) publishes COAG Regulation Impact Statements (RISs) and the OBPR's assessment of COAG RISs on its website as soon as practicable after a regulatory announcement is made, in consultation with the relevant Council, Forum or national standard-setting body (NSSB). Consequently, the RIS status is aggregated by Council, Forum or NSSB and is also reported 'live' in the following tables.

At the end of the 2016-17 financial year, 10 COAG RISs were assessed as compliant with the COAG RIS requirements for the 2016-17 period. One decision did not comply with the COAG best practice regulation requirements to prepare a RIS for consultation or for the final decision.

#### New South Wales Container Deposit Scheme (NSW Environment Protection Agency)

Department of Social Services (DSS) released a consultation RIS on the National Consumer Protection Framework for online wagering in Australia (The Framework). The Framework will seek to put in place nationally-consistent consumer protection measures for individuals using licensed online wagering products in Australia.

The Australian Building Codes Board released a COAG Consultation RIS examining current requirements for temperature control when replacing waterheaters in private residences to further reduce the risk of scalding injuries and fatalities.

#### Energy efficiency of residential and commercial lighting (COAG Energy Council)

The COAG Energy Council released a COAG Consultation RIS examining the adequacy of existing regulations on incandescent and halogen lamps, self-ballasted compact fluorescent lamps, double-capped fluorescent lamps and ballasts for fluorescent lamps. It also considers placing mandatory minimum energy performance requirements on light emitting diode (LED) lamp technology and non-integrated commercial luminaires.
