The Office of Best Practice Regulation (OBPR) publishes Regulation Impact Statements (RIS) and the OBPR's assessment of RISs on its website as soon as practicable after a regulatory announcement is made, in consultation with the relevant Council, Forum or national standard-setting body (NSSB). Consequently, the RIS status in aggregate and by Council, Forum or NSSB is also reported 'live' in the following tables.

In the financial year 2017-18, all 7 COAG RISs spanning the consultation and decision making phase were finalised and assessed as compliant; another 14 COAG consultation RISs were published for consultation.

New safety standard for freestanding and fixed alchol fuelled devices to meet stability tests, require a fuel container with a flame arrester (or an automatic fuel pump system) to be applied, and include display warnings on the device about refuelling hazards. The standard will further prevent the supply of table top ethanol burner devices as per 15 July 2017.

Changes to the vessel survey requirements to better align the survey frequency with the risk on individual vessel basis, provide for greater flexibility to reduce the number of out-of-water surveys required and allow surveys to be more easily allgined with other vessel maintenance activities.

The NSW Government sought to implement a Container Deposit Scheme to reduce the amount of litter from beverage containers. As the NSW Container Deposit Scheme laws may be inconsistent wit hthe Commonwealth mutual recognition law, which allow goods that are lawfully sold in another jurisdiction or in New Zealand to be sold in NSW without any further requirements, the NSW Government sought permanent exemption from mutual recognition arrangements.

The changes will increase Minimum Energy Performance Standard (MEPS) for commercial refrigerated display cabinets and refrigerated storage cabinets to harmonise with MEPS levels adopted by Europe in 2017. In addition, the changes will result in adopting international test standards and provide consumers with accessible and comparable information on refrigerated commercial cabinet energy efficiency.

The changes will increase Minimum Energy Performance Standard (MEPS) for household refrigators and freezers to harmonize with MEPS levels adopted by the United States in 2014. In addition, the changes will result in adopting international test standards, rather than the current regional specific Australian and New Zealand test standards, and provide consumers with more representative and comparable information on the in-home energy efficiency of refrigerators and freezers.

The COAG Energy Council agreed to further improve lighting energy efficiency regulation by phasing out inefficient halogen light bulbs in Australia and introducing minimum standards for LED light bulbs in Australia and New Zealand in line with European Union (EU) standards. The phase out will remove remaining incandescent light bulbs and a range of halogen light bulbs from the Australian market, where an equivalent LED light bulb is available. Timing of the new regulation will align with revised EU minimum standards that will apply to LED light bulbs (planned for September 2020).

The National Safety and Quality Health Service Standards are designed to protect the public from harm and to improve the quality of health care for consumers. The second edition of these standards addresses gaps identified in the first edition, including mental health and cognitive impairment, health literacy, end-of-life care and Aboriginal and Torres Strait Islander health. This version also streamlines the standards while making them clearer and easier to implement.

The Australian Building Codes Board released a COAG Consultation RIS investigating the need for accessible adult change facilities in public buildings for people with disabilities.

The Australian Building Codes Board released a COAG Consultation RIS investigating whether the National Construction Code (NCC) Deemed-to-Satisfy (DtS) Provisions need to be revised to require fire sprinkler systems in new multi-story Class 2 and 3 residential buildings above 3 storeys in height.

Energy efficiency for residential buildings: Nationwide House Energy Rating Scheme (NatHERS) heating and cooling load limits (The Australian Building Codes Board)

The Australian Building Codes Board released a COAG Consultation RIS investigating options to facilitate efficient energy use in both summer and winter for some new residential buildings.

Energy efficiency of commercial buildings (The Australian Building Codes Board)

The Australian Building Codes Board released a COAG Consultation RIS examining the impact of proposed changes to the energy efficiency requirements of the National Construction Code for commercial buildings (Class 3. 5-9 buildings and common areas of Class 2 buildings).

Consumer guarantee framework amendments (Legislative and Governance Forum on Consumer Affairs)

The Legislative and Governance Forum on Consumer Affairs released a COAG Consultation RIS examining possible options to amend the consumer guarantees within the Australian Consumer Law.

Quad Bike Safety (Australian Competition and Consumer Commission)

The Australian Competition and Consumer Commision released a COAG Consultation RIS examining measures to improve quad bike safety.

The Australian Government Department of the Treasury released a COAG Consultation RIS that explored options to regulate the expiry period of retail gift cards and vouchers.

Pregnancy warning labels on packaged alcoholic beverages (Australia and New Zealand Ministerial Forum on Food Regulation)

The Australia and New Zealand Ministerial Forum on Food Regulation (the Forum) released a COAG Consultation RIS on proposed regulatory and non-regulatory options for pregnancy warning labels on packaged alcoholic beverages. The objective of the options being considered is to provide a clear and easy to understand trigger to remind pregnant women, at both the point of sale and the potential point of consumption, to not drink alcohol.

Safety assurance for automated driving systems (National Transport Commission)

The National Transport Commission released a COAG Consultation RIS on the risk that may arise when automated vehicles become available. The consultation RIS identifies and assesses the relative costs and benefits of options to address risks posed to the uptake of automated driving system; the consulation RIS considers the safety risks of automated driving, the risk that a lack of consumer confidence will result in a reduction or delay in the uptake of automated driving systems and the risks to suppliers of these systems through inconsistent and/or uncertain regulatory barriers to the Australian market.

National Energy Guarantee (COAG Energy Council)

The COAG Energy Council released a COAG Consultation RIS to explore possible options for addressing climate and energy policy issues in the National Electricity Market. These options include the status quo, a National Energy Guarantee and a Physically Backed Contracts option. The Consultation RIS discusses issues around maintaining energy reliability, lowering emissions in line with international policy commitments and improving affordability.
