Five-yearly Reviews of Regulation

November 2012

Introduction

The Office of Best Practice Regulation (OBPR) has undertaken a screening process to identify regulation due to be reviewed in 2012 as a result of Recommendation 7.28 of *Rethinking Regulation - Report of the Taskforce on Reducing Regulatory Burdens on Business* (the Banks Review). The screening process found that of the 71 regulations made in 2007 which required a Regulation Impact Statement (RIS), four would require a five-yearly review beginning in 2012. This represents under six per cent of all regulation introduced in 2007 (details at <u>Appendix A</u>). To test these results, a similar study was conducted for regulation due for review in 2013 (details at <u>Appendix B</u>).

The screening process revealed that most regulation was subject to the sunsetting under the Legislative Instruments Act 2003 (LIA). The majority of the remaining regulation either contained an internal review mechanism or had already been reviewed by some other mechanism, such as broad ranging reviews, statutory reviews or inquiries. This left only a handful of regulations introduced in 2007 that would be subject to a five-yearly review and none of these could be considered priority areas for review by the administering agencies.

The screening process was conducted by the OBPR in consultation with relevant government agencies and the Office of Legislation Drafting and Publishing (OLDP) from the Attorney-General's Department.

Process

Recommendation 7.28 of the Banks Review states:

At least every 5 years, all regulation (not subject to sunset provisions) should, following a screening process, be reviewed, with the scope of the review tailored to the nature of the regulation and its perceived performance.

This recommendation was agreed by the Australian Government in August 2006. The first fiveyearly reviews are therefore to be conducted in 2012 for regulations created in 2007. With this in mind the OBPR has conducted a screening process to indentify regulations that would be due for a five-yearly review in 2012 and 2013.

Any legislative amendment that has a significant regulatory impact is subject to a Regulation Impact Statement (RIS) when the decision to regulate is made. These regulations are listed in



OBPR's Best Practice Regulation Report for each financial year. Using data from the 2006-07 and 2007-08 reports, it was determined that 71 regulations were created in 2007 which required a RIS. Of these 44 were excluded from the five year review process due to sunsetting under the LIA (this number was confirmed by OLDP), nine were exempt from sunsetting (eight of which were safety related, including six which involved vehicle standards and two which involved civil aviation), 13 had already been subject to review and one was repealed. This left only four regulations falling within scope for review in 2012 (details at <u>Appendix A</u>). Contact with the agencies responsible for these regulations revealed that one had been reviewed in 2010, one was currently under review, one was to be reviewed in 2015 and the final regulation had implemented a range of minor and machinery changes that were not a priority for further review.

To confirm that the result for regulation introduced in 2007 was not an aberration, the screening process was undertaken again for regulation introduced in 2008 which would be subject to a five-yearly review in 2013. A similar outcome was achieved and of the 78 regulations created 29 were excluded from the five-year review process due to sunsetting, 15 were exempt from sunsetting, 20 had already been subject to review and ten had been repealed or no longer operated (details at <u>Appendix B</u>). This left only four regulations falling within scope for review in 2013, one each of which involved vehicle standards and regulation of the automatic teller machine access regime and two which involved regulation of civil aviation.

Other Reviews

The analysis conducted by OBPR found that a large number of regulations had already been subjected to various review processes, including:

- broad reaching reviews (such as the Henry Tax Review or the Cooper Superannuation Review);
- statutory reviews (such as the Statutory Review of the Gene Technology Act 2000);
- inquiries; and
- other ad-hoc reviews.

Such reviews and inquiries are regularly conducted by government or independent bodies and cover significant bodies of regulation, particularly regulation that relates to rapidly changing or developing areas of the economy. A current example is the convergence review into the policy and regulatory frameworks that apply to the converged media and communications landscape in Australia.

Sunsetting

The Australian Government has introduced a sunsetting regime under the LIA. This act provides that all legislative instruments cease automatically after ten years of operation unless the instruments are exempt or specific steps are taken to preserve them. The purpose of sunsetting is to encourage regular review of legislative instruments and to reduce unnecessary and redundant regulation, making it easier to understand and comply with the law. A significant amount of work is being undertaken by Australian Government agencies to facilitate the phased introduction of sunsetting from 2015.

The Pre-2008 Review of Subordinate Regulation

In 2009 the Australian Government undertook a review of all pre-2008 subordinate regulation (the Pre-2008 Review), which reviewed over 11,000 pieces of legislation. The Pre-2008 Review



was coordinated by the Department of Finance and Deregulation, which worked closely with all Commonwealth portfolios to undertake a comprehensive assessment of legislative instruments that had not been reviewed elsewhere since the beginning of 2008. The Pre-2008 Review found that the stock of Commonwealth subordinate regulation is reviewed regularly for continued policy relevance by agencies, though reviews are not systematically conducted.

Productivity Commission Review

Consistent with the OBPR's findings, the Productivity Commission report *Identifying and Evaluating Regulatory Reforms*, published in December 2011, has recommended that the fiveyearly default review requirement be dispensed with, provided the Australian Government's best practice regulation guidelines were modified to:

- require a formal review and performance measurement plan in cases where the expected impact of a proposed regulation is rated as 'major' by the OBPR;
- encourage the use of embedded statutory reviews for regulation with significant uncertainty regarding its effectiveness or impact;
- ensure that all reviews foreshadowed in RISs take place within five years; and
- ensure that any proposed review is proportionate to the potential impact of the regulation.

Conclusion

The OBPR's review of regulation introduced in 2007 and 2008 has met the Australian Government's commitment to the five-yearly review of regulation and demonstrated that the process is of little value in identifying regulatory reform targets. The widespread use of internal review provisions in existing regulation, the commencement of sunsetting arrangements under the LIA from 2015 and the range of other reviews that the government regularly undertakes mean that five-yearly default reviews are unnecessary, are an ineffective mechanism to identify inefficient regulation and will therefore be discontinued.
